Zach Rivers has been selected as a 2019 UMN CTSI TL1 Program awardee through the University of Minnesota CTSI - Research Education, Training, and Career Development (CTSI-Ed) group. The program's mission is to improve human health by catalyzing and accelerating the translation of research findings to the community. The two-year training program integrates a mentored research experience, an individualized curriculum, and professional development activities that focus on team-based research and effective collaboration and communication with the larger community.

Alina Cernasev, Awarded the 2018-19 Doctoral Dissertation Fellowship (DDF)

This 9-month award provides a full stipend of \$25,000 plus tuition and fringe benefits, as well as a \$1,000 conference presentation grant. Outstanding doctoral candidates from across the University were nominated. 102 fellowships were awarded (53% award rate). Alina's dissertation work involves the examination of African-born HIV patients' socio-cultural, socio-economic, and personal beliefs and how these are associated with medication use.

Alina Cernasev has been elected by her peers to serve as **Student Liaison in the Pharmacy Section for the American Public Health Association**. The 1-year term begins on November 15, following the 2018 Annual Meeting in San Diego, CA. The American Public Health Association has the goal of "creating the healthiest nation in one generation." Alina's participation will help build an engaging public health movement.








International Social Pharmacy Workshop (ISPW) July 2018





Djenane Oliveira and Mateus Alves awarded the Distinguished Leadership Award for Internationals

SAPh PhD program alums, Dr. Djenane Oliveira, '03 PhD and Dr. Mateus Alves, '12 PhD were presented with the Distinguished Leadership Award for Internationals on November 29, 2018. This is a University-wide award and is conferred to individuals who have attained unusual distinction as professionals in their careers within institutions and have demonstrated sustained, outstanding achievement and leadership.

They provide extraordinary leadership in Brazil for leading transformations in medication use and patient-centered care. Together they have been able to found and direct the Centro de Estudos em Atenção Farmacêutica - CEAF at the Universidade Federal de Minas Gerais. Their mission is to reach a higher standard for medication use in Latin America through the delivery of comprehensive medication management services. Their vision is to become the most trusted institutional reference in comprehensive medication management services in Latin America. Their goals are to (a) deliver care to patients through medication management services; (b) prepare competent pharmacist practitioners to provide quality services through training programs; (c) establish effective and efficient practices through practice development techniques, and (d) evaluate and analyze the quality of patient services through sophisticated and state of the art evaluation techniques.

Through this center, they have served as public policy experts for (a) Unimed-BH (Brazilian Private Health Care Plan) in which they developed and supervised medication management services at ambulatory clinics in the City of Belo Horizonte and (b) the Brazilian Ministry of Health in which they provided technical supervision of the implementation process of medication management services in two cities of the State of Minas Gerais. Twenty pharmacists were trained and supervised as they took care of over 3000 patients.

Greg Rhee, '16 PhD recently published a study in the Journals of Gerontology, Series A: Biological Sciences and Medical Sciences examining prescribing trends of co-medicating in outpatient settings of opioids and benzodiazepines. He used a national representative sample to estimate national rates and prescribing trends and found that: the rate of prescription benzodiazepines alone increased from 4.8 percent in 2006-2007 to 6.2 percent in 2014-2015; the rate of prescription opioids alone increased from 5.9 percent in 2006-2007 to 10 percent in 2014-2015; and the co-prescribing rate of both benzodiazepines and opioids increased over time from 1.1 percent in 2006-2007 to 2.7 percent in 2014-2015.

Dr. Rhee identified demographic and clinical factors associated with co-prescriptions of benzodiazepines and opioids. These correlating independent factors associated with higher co-prescriptions include: being of the female sex, a visit for chronic care, receipt of six or more concomitantly prescribed medications, and clinical diagnoses of anxiety and pain.

He makes the following recommendations on how health care providers can reduce co-prescribing opioids and benzodiazepines: health care providers should be more careful when prescribing these medications in older adults; health care providers can prescribe safer alternatives (e.g., non-opioid analgesics for opioids) to minimize potentially avoidable adverse drug events; and pharmacists can provide detailed pharmaceutical information and outreach by collaborating with the clinical team. This study was funded by the National Institute on Aging and the National Institutes of Health.

Thomas Rector, PhD '83 passed away on Thursday, February 1, 2018. Dr. Rector was the 33rd PhD graduate of the SAPh Graduate Program. He was part of the Kellogg Clinical Scholars Program and his dissertation was entitled "An Epidemiological Evaluation of the Potential Association between Central Nervous System Depressants and Nocturnal Death in the Elderly."

Dr. Rector developed **The Minnesota Living with Heart Failure Questionnaire.** This instrument is a reliable and valid patient-oriented measure of the adverse effects of heart failure on their lives. The questionnaire is comprised of 21 important physical, emotional and socioeconomic ways heart failure can adversely affect a patient's life. The instrument can be used as a key outcome measure in studies and evaluations of outpatients with symptomatic (NYHA class II to IV) heart failure with a reduced or preserved ejection fraction. This patient-reported outcome can be used to determine whether a treatment for heart failure is effective for improving patients' quality of life by reducing the adverse impact of heart failure.

Dr. Rector was a scientist working at the Center for Chronic Disease Outcomes Research, Department of Veteran Affairs.


