



#### In Memory

**Don Uden**, PharmD, professor in the Department of Pharmaceutical Care & Health Systems and SAPh Graduate Program, died on Saturday, March 21, 2020.

Don, was part of the College of Pharmacy and University community for more than 30 years and was an inspirational mentor who had a profound impact on the lives of our College of Pharmacy community. He was generous with his time and talents to help others' professional growth and shared his knowledge with his students in the classroom.

Don also served in leadership positions within the college, including as associate dean for Student Services from 2000-2007. He advised the CLARION student organization to drive pharmacy's role as a leader in interprofessional education forward and was actively involved in leading the Minnesota Rural Health School.

Don was awarded fellow status with the American College of Clinical Pharmacy (ACCP) in 1979 and influential in the evolution of that professional organization. He was the recipient of the **University of Minnesota Graduate-Professional Teaching Award in 2003**, the Center for Health Interprofessional Program (CHIP) Champion in 2005 and the Weaver Medal in 2017.


